Sharing personal data with third parties

Cookies, or similar techniques, that we use

Streetlife only uses technical, functional and analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you visit this website for the first time. The cookies we use are necessary for the technical operation of the website and your convenience. They ensure that the website works properly and remember your preferred settings, for example. Cookies also help us to optimise our website. You can disable cookies by changing the settings of your internet browser so that it no longer stores cookies. You can also delete all information previously stored through your browser settings.

Accessing, correcting or deleting personal data
